## **CoDA Literature Committee**

The National Literature Committee (NLC) met in LA from 7/19-7/22 for its second major meeting of the year. Overall, a lot was accomplished, and our entire agenda was completed. This report will update you on the major writing tasks that were finalized and the key decisions that the NLC made concerning next year's agenda and this year's National Service Conference (NSC) proposals.

The NLC completed work on several major writing projects. Step and Tradition Ten of the Workbook project were reviewed, reedited, and finalized. We also completed the final major revisions to Step and Tradition Eleven. Lastly, we completed final edits to Step Twelve. The NLC felt very good about putting most of this project "to bed", as it has been a challenging, long-term commitment. The NLC hopes to complete the final drafting of Tradition Twelve in August and present all five pieces to the NSC in September. Completing these pieces was intensive and took up a majority of the NLC's time at this meeting.

The NLC also began or completed work on several pending projects. Karyn J. kindly agreed to explore the implementation of the Literature Sampler Project (LSP) and was appointed Project leader by a 6-0 vote at the LA meeting. The intent of the LSP is to compile a packet of new and older conference-approved literature that can be distributed for free to new and/or active groups. As Project leader, Karyn J. is exploring this idea and will present a proposal to the NLC in August. The NLC is deeply grateful to Karyn J. for agreeing to head this project, and depending on her recommendation and the group conscience of the NLC, the NLC may also present a proposal for the LSP to the NSC this fall. The NLC is also considering recommendations such as expanding its literature blurb effort by posting descriptions of NLC literature on the CoDA web site.

The NLC also made its final group conscience decisions concerning the *Experiences in Crosstalk* (EIC) pamphlet. The NLC voted 7-1 in favor of submitting a revised draft of the EIC piece which Allison F. and Judi T. worked on this year. The NLC group conscience at the LA meeting was that crosstalk is an important issue to share with the Fellowship. The considerable variety of responses presented in the EIC pamphlet concerning what Crosstalk is, how it's defined, and who defines it, etc., testifies to our sense that

crosstalk is an issue about which many CoDA members want more information so they can make the most informed decisions possible concerning how crosstalk is handled in their meetings. The NLC devoted a great deal of time and energy to producing the EIC pamphlet, and we feel that it will make an important addition to our current literature. We are deeply indebted to Judi T., who initiated this project, and Allison F., who did additional edits with Judi T. We are also indebted to all the NLC members from last year's committee, headed by Marcie L., and this year's committee for their ongoing work on this project. Considering the remarkable variety of input this project has received from all members of the Fellowship, it is probably the richest "group conscience" piece of literature that the NLC has produced thus far.

The NLC also made a major decision about one project it was considering for next year, namely, it was decided by a 6-0 vote that the NLC did not want to revise the CoDA Book. After a lengthy discussion, it was decided by a 6-0 vote (one member had to leave early unfortunately), that the NLC did not want to revise the CoDA Book. While everyone felt that the CoDA Book would benefit from further editing, it was felt that recommending any major revisions to the book might cause too much dissension within the Fellowship, and the NLC feels strongly about serving the Fellowship as positively as possible and being a source of unity, not dissension. The NLC feels that the potential disadvantages to Fellowship unity outweigh any advantages a revision would produce.

The CoDA Book clearly serves many groups quite well and is still the leading piece of literature sold by the Fellowship (\$30,878.80 in sales from Jan. through June 2001) and also, a major part of our history. Therefore, although revising the book seemed inviting in many ways, the NLC group conscience was to let it go. Moreover, the NLC felt that its current autonomy and ability to select, propose, and complete projects--such as the Steps and Traditions Workbook, would be jeopardized if the NLC took on a project as emotionally charged as the CoDA Book. For now, the NLC will recommend to the NSC that any outstanding grammatical edits be completed to the CoDA Book before its next printing, perhaps by the Recovery Writers in Action Committee, or a new committee specifically charged with that effort. Regardless of who completes this work, the NLC feels it is extremely important that the CoDA Book be as cleanly edited as possible, since it probably represents our Fellowship to the public more than any other single piece of literature.

Along with deciding not to recommend any major revisions to the CoDA Book, the NLC also decided to table the new Preamble and Welcome project for this year by a 6-0 vote. The NLC group conscience directed that we give priority to other NSC projects for this year's NSC. Although considerable work was done on both the Preamble and Welcome during the last year, and the Preamble must be addressed as a previous States Issue at this year's NSC, it was decided that, although not "perfect," both pieces are currently serving their purpose.

In lieu of working on the CoDA book project, the NLC voted 6-0 in favor of exploring a separate book project that has tentatively been titled, <u>The Expanded Steps and</u> <u>Traditions Workbook</u>. Although only in the brainstorming stage, we are considering an expanded version of our current workbook project, which is nearing completion. This workbook could include all the previously published workbook sections compiled in one volume as well as additional pieces of literature that the NLC has completed or is currently working; for example, The Expanded Workbook might include excerpts from the *Experiences In Crosstalk* piece; <u>In This Moment</u> meditations; *Boundaries; Tools of Recovery; Why is Using Conference-Approved Literature Vital to CoDA Unity*? etc. Moreover, the NLC might garner new stories by Fellowship members for an expanded workbook section. These stories/anecdotes could include CoDA members with long-term recovery (perhaps even members who wrote stories for the original CoDA Book) who may wish to share their experience, strength, and hope. The NLC feels far more

optimistic about pursuing this book project as it anticipates much more support from the Fellowship. Although no specific Project leader has been appointed, the NLC plans to explore this idea in depth this year, and make its recommendation to the NSC in 2002. Because of its excellent record of completing writing projects—both large and small—the NLC feels confident that it could successfully complete this effort also.

The NLC also completed more planning work on the ITM project, which Kay M. kindly agreed to head at our last meeting and was elected to do so by an 8-0 vote. Currently, Kay is setting up a system whereby meditations and release forms can be garnered from members of the Fellowship via the NLC's new web site description. Again, the NLC is deeply indebted to Kay M. for taking on the considerable task of keeping the ITM project on course. While the NLC plans to continue supporting Kay's efforts on this project next year, this project will not be designated as our primary effort (see previous paragraph). Any CoDA members interested in submitting ITM meditations should see the appropriate page at our CoDA web site. We could use your support.

Lastly, we reviewed the final draft of the CoDA Poster project that Roger P. tirelessly worked on this year. The NLC was extremely pleased with the final version of the poster (which we'll share at Conference) and voted 8-0 to send it to the printers. We are deeply grateful to Roger for patiently working through the seemingly endless changes that the group conscience process entailed. We believe that the new CoDA poster will be an excellent tool for attracting new members to CoDA and informing them about our Fellowship, without breaking our Tradition of being non-promotional.

We've answered approximately 950 e-mails from 10/00 to 7/15/00. Last year's total from 10/99 to 9/00 was 867. We still have a couple of months to go before the end of this year and we are well pass last year's total.
