It was a successful and productive meeting that agreed:

We will cease referring to CoDA "national " (and call if CoDA or CoDA Inc.)

We will change name from National Service Conference to **C**oDA **S**ervice **C**onference. We will find a way to give voice and vote for non-US Delegates to be determined through group conscience process.

We will change names of Standing Committees to eliminate the word "national"

Allow non-US participation on CoDA Committees---this already exists.

We will clarify expectations and responsibilities between CoDA Inc and CoDA WS.

We will not now develop a contract between CoDA Inc and CoDA WS.

Interim plan to improve communication:

Ask WS member to join Board teleconference

Routine communication throughout the year

State/Regional Issues to be disseminated to both Boards, in both directions

Interim **funding** of WS will proceed as it does for standing committees. WS will follow the same process of submitting a budget, and goals, for approval by CoDA Service Conference. Expense reimbursement process to follow Committee process.

For CoDA, "there is but one ultimate authority; a loving Higher Power as expressed to our group conscience" of our CoDA Fellowship. This is the guiding principle by which we shall proceed. (Tradition Two)

Representatives of the Literature Committee, SSC, Boards and other appropriate committees shall work together to create a process for translation, licensing, publication and distribution of literature/service items, using modern technology wherever possible.

Further along in the process, the revision of the Service Manual and other documents will be addressed.

QSR welcomes reports from all service entities to inform the Fellowship.

A task force was appointed to devise a multi-year plan that would:
Create a consistent multi-year service plan
Use step-by-step implementation of recommendations, built on common vision
Be inclusive of SSC, Boards, Finance
Develop a **preliminary plan for presentation at 2004 CSC** (CoDA Service Conference)

Outreach Committee Report

The Outreach Committee is always interested in accepting applications for service from the CoDA Fellowship. Our experience is that at least one year in CoDA with preferably some experience in local, regional or national service helps. What is also almost a necessity is an affinity for email. The service that the Outreach Committee performs involves a lot of email reading and often times, group discussion. If you enjoy email, this might be a great forum for you to perform service work. Serving on this committee has provided many of us the opportunity to enhance our ability to participate in a group conscience and has also helped many of us in our individual recoveries.

We continue to keep track of the overall number of emails we receive from the fellowship. Average weekly totals for 2004 are around 25 emails. We are seeing an increase in the number of emails written in Spanish. We refer those to our bilingual volunteer, Mary Elizabeth of MD. We are also seeing an increase in the number of inquiries about online fellowship opportunities. For those, we have a rather generic reply about current offerings as we await the findings of the group conscience work of the newly established Online Support Committee (osc@coda.org).

A new event that occurred in April of 2004 is that we added our first international volunteer to the committee. Janie D from Australia is an observer on the committee. Also, one of our California volunteers resigned. This means we could use another person willing to learn the ropes and take on weekly rotations.

One of the most important ways that an individual can be of service to Outreach without actually volunteering on the committee is to ensure that the meeting listing for the meeting that you attend is correct and up to date. While Outreach does not maintain the database (this is done by Fellowship Services whom can be emailed

at meeting@coda.org), we do use that information to help newcomers find meetings. For this reason, it is important that defunct meeting listings are removed from the database and that all information for existing meetings is correct.

CoDA Teens would like additional help from anyone to formulate ideas for brochures, and to help merge the final documents for the manual once we have finished the drafting process. Other than that we are all doing well and look forward to seeing everyone at the next conference.

Finances for CoDA, Inc. are about as expected. Income is down and expenses are running below budgeted. 7Th Tradition donations are down and so is revenue from the sale of literature. We do not quite have our Prudent Reserve figure met. With our current budget, we would need 3 times \$122,888.00, or \$368,664.00. However, our actual expenses have been only about 37 percent of the budget. The Finance Committee recommends that CoDA, Inc. continue to spend wisely and frugally. About the Meeting List and Contact Information

A few years ago, CoDA adopted a policy of not listing meetings in our database unless someone has agreed to serve as meeting contact. The policy was developed to solve a problem we had then. At that time, we had a very high volume of complaints about out of date meeting information.

Under our old policy, we kept meetings on the list even if we had not heard from them in years and even if there was no contact. The thinking was – we don't have enough meetings on the list as it is, and if we take them off just because people are too busy to serve as meeting contact, we shut people out of recovery who then can't find the meeting. People were worried about "throwing the baby out with the bath water". If we didn't have "proof" that a meeting wasn't thriving, we didn't de-list it.

Unfortunately, people spent a lot of time driving to dead meetings as the result of this policy. When a meeting folded, most of the time nobody thought to let us know. People became reluctant to attend a meeting unless they could call someone to verify it. (This remains true today.) We got very upset letters and emails about people wasting time going to meetings that don't exist. Many people were concerned about the message we were sending to newcomers, who might not keep trying to find a meeting if the first one they tried to find was dead. So, we changed the policy to swing towards accuracy in the database. We now attempt to make contact with meetings who have not sent in an update in more than two years, asking them to provide an update. If they don't, or we can't reach them, they go off of the list. If a meeting contact writes to us and says they can't serve any longer, and nobody else is willing to, either, we take them off of the active search list. We do keep a record ourselves, so we can try to write to the meeting, asking for updates and hoping they are able to provide a contact. But in cases where we are left with no way to contact a meeting, we are left with no alternative but de-listing them from our meeting search under our current policy.

It may be time to discuss this policy once again. We have done a good job of increasing meeting list accuracy, which is what the Fellowship told us it wanted us to do. Now, we hear complaints from time to time, as people want us to list their meeting but don't want to provide any contact information. We have seen the negative consequences of listing meetings like that, but perhaps the negative consequences of not listing them are also substantial. We invite our members to discuss this issue and report back to us your thoughts. If it seems consensus is swinging towards less accuracy and more meetings listed, whether we know they are there or not,

we can change our listing policy. Since it has been a few years since the last time the Fellowship gave input, we'd like to hear from folks again.
