#### **CoDA Board**

The board of trustees has been meeting monthly since CSC including a face to face in June.

Our Treasurer, Denny, has had to resign after his wife, Robert, suffered a stroke. We are all hoping for the best, and understand the need to take care of his family. We appreciate all the work he did for the fellowship, and he will be sorely missed. We voted to move Addie from Alternate to Trustee, and she has taken on the duties of Treasurer. We also moved around some liaison responsibilities, to better serve the fellowship.Our meeting time has changed from 7:45 to 8 PM eastern, on the second Thursday of each month. We are continuing our work on the website. We have made decisions on several items regarding the website – 1) we will be replacing the current meeting locator function with a new product that is more user friendly very soon. 2) We will be converting from our current platform (Cold Fusion) to a better, more user friendly, platform. 3) We will be sending out an invitation to within and outside CoDA for interested companies.

The board has been working on improving the communication with the committees and the fellowship. Our workgroups have really helped ease the load on the board, while allowing a focused approach to many things. Two of our initiatives (goals) are being actively worked on, both having to do with structure.

The board will be sending out requests for members who would be willing to be Trustees or alternate Trustees, along with the requirements for being a trustee. We hope you will consider serving on the Board – voting takes place at CSC in October, 2017.

The board began planning for CSC, including possibly audio streaming (at least part) to those requesting access.

Fellowship Forum – This will be a call, inviting any interested parties, to join in discussing items related to the fellowship and also to CSC. The first will be July 22, time to be announced later, to discuss 1. audio streaming at CSC (do you want it? How best to deliver? What do you want to hear, if you want streaming? And 2. This one will be discussing some motions that will come to the floor of CSC, and other matters of interest to the fellowship. ## **Board - SOS (Our Management Company)**

This quarter was busy with several projects, including a Board Face To Face meeting and follow-up.

**Accounting:** Worked with the Treasurer and Finance Committee Chair for ongoing accounting tasks including daily entries and bank reconciliations. Worked with the Board to identify and secure a new nonprofit CPA for annual 990 taxes. Helped transition the interim Treasurer.

**Board:** Assist the Board of Trustees in different ways including board meeting attendance, prep, minutes and follow-up work. Respond to requests as needed. Keep in the loop on all Board issues. Face to Face Prep for June meeting in Phoenix, attendance, as well as follow-up. Assisted in securing event cancellation insurance for the 2017 CSC.

**Phone Calls:** Ongoing phone calls for CoDA weekly, including follow-up with Communications Chair. The volume of calls is steady. We track each call in SmartSheet and share information weekly with the Communications Chair.

**Policies and Procedures:** This is an ongoing project. No committees worked on this quarter.

**Website:** We spent a large amount of time working with the board on website solutions and ongoing maintenance.

We have been very interactive with our Web, Communications, Events, Accounting and Board liaisons and welcome the opportunity to continue to assist in ongoing projects. Thank you for the opportunity.

Highlights of the last quarter for me were 2 upgrades to our software. You may have noticed that the appearance of our emails is greatly improved. We now have approximately 14 color "themes" to choose from. We recently revisited the gc on which color theme to use & felt the brown theme was more readable & we have changed. We are still working with the CoRe webmaster on trying to move the "remove me" button to the top of each email.

My #1 current project is gearing up for my part in making CSC 2017 information readily available to the CoDA fellowship. We are also considering a project to move choosing of which archived emails to send on weeks where there is no new content for the General Announcements list to 2 members of the former CoDA Communications Friday Fellowship Group.

Since the last QSR was written (4/8/17) we have sent out 31 announcements on the Main Announcements list; + the Co-NNections weekly readings.

We have a favor to ask of our members who use Email Providers with "unsubscribe buttons" or links.

# On the bottom right of every email we send out there is a button that says,

#### "Unsubscribe Automatically"

By using that method you can easily unsubscribe from the list with 1 click and no damage to CoDA.

We would greatly appreciate it if you would not use your provider's "unsubscribe" or "spam" button.

#### There are 2 reasons:

- 1. Every time someone unsubscribes in that manner, the email provider puts it down as a negative "mark" against CoDA; the more of those they see, the less chance that members wanting to receive our emails will get them.
- 2. When you push the provider's "unsubscribe" or "spam" button, a paid CoDA "special worker" has to manually unsubscribe you. This takes away from your 7th tradition donations, & from the time that "special worker" has allotted for other tasks for the good of CoDA.

#### **CoDA Resource Publishing (CoRe)**

The Core Board met via phone conference in April and May, with a F2F in Atlanta in June. The continued focus of the meetings has been to advance the strategic planning goals developed during the February F2F.

The renewed CoDA/CoRe contract has been signed and consequently the Royalty paid to CoDA will be increased from 30% to 40% from July.

As part of our sustainability initiative CoRe is in the process of appointing an Attorney for corporate legal matters as needed and in engaging SOS to write a Procedure Manual.

We published the 12 + 12 Work book in electronic format in both English and Spanish. They are both available in the Kindle store along with InThis Moment, the Spanish pocket edition and the Blue Book. The Workbooks and Blue Book are also available in iBooks. We have reprinted Crosstalk, Carrying the Message and What Is Coda both flat and folded. In July we will be reprinting Am I CoDependent and Attending Meetings as well as the Sponsorship booklet in Spanish.

We are experiencing problems with the e-store website and Doug has been diligently working on trying to resolve them. We are able to take orders via phone and email, and are still operational.

One of the big projects during 2017 Q2 has been to make free literature available to new meetings. We can report the project is up and running. The free literature kit program provides a selection of CoDA literature to 1. New CoDA meetings and 2. All Spanish CoDA meetings

So far, 20 Spanish kits were delivered to CoDA Colombia for distribution and 7 kits were sent out to Spanish meetings in the US. Four new CoDA meetings have applied for kits. We see this initiative as an important way of spreading the word and demonstrating what Spanish literature is available to the fellowship

Also we have teamed up with SPO so as to make What is Coda and Sponsorship in CoDA available for free download from the CoDA website.

We are exploring the cost of printing in large font as requested.

We will continue to meet monthly on concall and our next F2F will be at CSC in November.

Friday Fellowship Item Review Group:

Friday Fellowship Items were published every week for 10 weeks beginning April 14.

It was then suspended as a weekly effort due to lack of additional authors and the difficulty maintaining focus only on CoDA content by reviewers given the short timeframe of the weekly series.

Some members of the review group have taken on advising the Mail List coordinator in choosing materials from the archives to publish when there is no other content needing to be published on CoDA Announcements.

#### Core Committee:

The committee is continuing the work of three or four 2016 CSC delegates attempting to clarify the meeting designation information in the meeting handbook.

Since the committee's work requires extensive interaction with functions provided by Co-Dependents Anonymous, the Corporation, the committee is preparing a motion to establish a task force that would clarify boundaries and the respective roles of the Fellowship, especially Fellowship committees and corporate entities.

#### **Co-NNections Committee**

This quarter the Co-NNections committee amended the CoDA Policy and Procedure Manual to make it current and to insure it accurately reflects our mission. The committee continues to study our policies & Procedures Manual and our coda.org committee page for accuracy, clarity and improvement.

We rewrote descriptions of the Committee functions and mission for the Co-NNections page in two places. As well as in the Trusted Servants area of coda.org. In addition, we updated the language in the Fellowship Service Manual for the same purposes.

We have submitted all the second quarter approved committee meeting minutes to the board for web site storage.

Our service positions continue as chair: Don B Southern California, Geff R vice chair Washington, Andreas M liaison to the Committee of the whole from Meeting in Print, United Kingdom and Switzerland.

We now have eleven members on the Coda Co-NNections Committee.

Our most challenging issue this quarter was the crash of coda.org and the breaking of the submission link on the Co-NNections page. The crash and break changed the flow of Fellowship Recovery Stories from a steady flow to a trickle. Both the Weekly Reading subscribers and the readers of Meeting in Print were profoundly impacted. Despite this challenge the Fellowship contributed enough original recovery writings and Weekly Reading was able to send out a original work each week. Both Weekly Reading and Meeting in Print supply of recovery stories was reduced and by June 30, 2017 have not regained their first quarter healthy flow of fellowship participation.

The Meeting in Print Subcommittee

Meeting in Print created a new copyright waiver to include text, audio and video submissions and a new Fellowship Guidelines for audio and video submissions. Both Documents were GC'd by the committee of the whole and approved by the Board of Trustees.

Meeting in Print continues their quarterly issues and have already laid out the next three issues for 2017 publication. The Subcommittee will add audio and video fellowship submissions to future issues. # 2016 CoDA Service Conference, annual business meeting, Survey Highlights

There were 21 responders, of which, 16 were delegates (29 delegates attended the 2016 CSC).

Using the 7<sup>th</sup> Tradition Donations

63 % felt that morning coffee SHOULD NOT BE funded

81% felt that the recruitment lunch SHOULD BE funded (while there is no budget for 2017 lunch, Events Committee has proposed each committee donate \$50 so we can pick up sandwiches and bring them to hospitality suite on Tuesday.)

Frequency for CoDA Meetings

66% would like CoDA meeting before and after CSC every day.

15% wanted a CoDA meeting at lunch

In other words, the majority do not want a CoDA meeting over lunch.

Electronic versus Printed Delegate Package

53% felt the electronic delivery of the delegate package was good

14% felt the electronic delivery of the delegate package was poor

In other words, the majority is satisfied with downloading or receiving the package electronically.

#### **Finance Committee**

April, May, and June, 2017

During the 2nd quarter the committee met 3 times using the new product made available by the board for videoconferencing. We worked on a set of **Guidelines for establishing and working a rotation for funding face to face CoDA Committee meetings**. We presented this to the chairs forum for input and approval and are sending it on to the Board. It is our desire to present a budget for 2018 based on this proposal which will allow some committees to have a face to face each year on a rotating basis instead of each committee's budget not funding. The

new process will be overseen by a 2x2 workgroup from Finance and the Board. Although we think we have covered most of the issues, it is something that will need to be refined as we find issues as it is implemented.

# **Spanish Outreach Committee (SPO)**

**Spanish Outreach** answers emails and phone calls from codependents who contact CoDA, Inc. in Spanish; corrects and proofreads CoDA literature that has been translated into Spanish and proofs items that are about to be reprinted by CoRe. SPO also helps Spanish speakers to set up new CoDA meetings and order literature. SPO redirects inquiries about the translation of CoDA materials to the Translation Management Committee. SPO manages the Spanish announcements list, **Espcoda**.

**Outreach activity:** Spanish Outreach exchanged 657 messages, including 43 inquiries about how to find a meeting and 62 inquiries from members of the fellowship and other CoDA Committees. The remaining 522 messages consisted of discussions between committee members. This quarter the Spanish Toll-Free CoDA line (+1 888-444-2379) fielded 29 calls.

**Proofreading**: At the request of the Board, translated documents are being proofed for posting on the website as downloadable documents. SPO also submitted 'Sponsorship in CoDA' and 'What is CoDA?' to CoRe.

**Webpage**: To date, SPO has not seen any action on the matter of the \$8,000 expenditure approved at the 2016 CoDA Service Conference for the improvement of the Spanish side of the CoDA, Inc. website.

**Teleconferences**: We met 8 times this quarter, including once, on May 3<sup>rd</sup>, with the liaison and alternate liaison.

**Espcoda:** Nine new subscribers to this CoDA Spanish announcement list were registered. There are now 383 subscribers.

**Accomplishments this quarter:** Despite being in a transitional period due to the training of two new members, the departure of two other members, a change of Board liaison and the search for new members, the committee provided the Spanish versions of several downloadable documents for the CoDA website.

#### Report

The New York Voting Entity (VE) was notified that their VE Issue (VEI), to make No Crosstalk mandatory at CoDA meetings, was not approved. They were also notified that, according to our VEI procedure, if they so choose they may bring this issue as a motion to the CoDA Service Conference (CSC).

A number of corrections were made to the Fellowship Service Manual (FSM) fixing errors that happened over the past 6 years. These corrected versions are available on the CoDA.org website.

Unfortunately, Renu was not able to join us for our June 23-25 face to face (F2F) meeting. We successfully completed our agenda during the F2F including reviewing the entire FSM for areas needing improvement. New FSM versions will be presented for approval at CSC.

During the F2F we also discussed at length the problems we see at the CoDA Inc. service level and proposed a number of suggestions on how CoDA Inc. might move forward with fixing these problems. Any such improvements will focus on our primary spiritual aim, which is to carry the message to other codependents who still suffer, and on making the most efficient use of our financial resources. All such suggestions are currently being reviewed with the Chairs Forum or with the Legal Group. Hopefully some of these will be brought to CSC for approval.

#### **Translation Management Committee (TMC)**

The committee, in conjunction with the CoDA Board, continues to develop and refine the legal paperwork and procedures necessary for CoDA, Inc. to maintain its legal copyright and intellectual property interests. This process is ongoing.

The Board has also decided to have 2 Board members as active participants on TMC. The plan is to have interlinking of responsibilities between CoDA Inc and TMC to smooth the process of translation and copyright applications. 2x2 meetings with the CoDA board also continue.

The Board continues to work through the procedural flow charts (Preliminary Contact for Translation and/or Publication, Translation, and Publication and Distribution Procedures) and the TMC Policies and Procedures Manual. Once this process is complete we hope to have them posted on the CoDA website.

There have been issues in the past with royalty payments not being paid on literature published elsewhere in the world. This is now being discussed along with the Finance committee and the CoDA Board to understand how best to collect royalty payments from outside the USA. This process needs to be simple and affordable for all.

Two members continue to attend the Committee Chairs monthly meetings.

We have been lucky enough to receive funding to hold a committee face to face meeting this year.

TMC is currently responding to requests from Mallorca, Brazil, Greece, Colombia, Russia, Spain and Guatemala. P&D Agreements with UK and Canada are also currently being renegotiated.
